AN ACT to amend the Cinematograph Act; Chap. 20:10; the Registration of Clubs; Chap. 21:01; the Theatres and Dance Hall Act, Chap. 21:03, the Motor Vehicles and Road Traffic Act, Chap. 48:50; the Companies Act, Chap 81:01; the Bills of Sale Act, Chap. 82:32; the Money Lenders Act, Chap. 84:04; the Pawnbrokers Act, Chap. 84:05; the Licensing of Dealers (Precious Metals and Stones) Act, Chap. 84:06 and the Public Health Ordinance, Ch. 12 No. 4 in response to the 2019 Novel Coronavirus (2019-nCoV) and for related matters

THE MISCELLANEOUS PROVISIONS [2019 NOVEL
CORONAVIRUS (2019-NCOV)] BILL, 2020

Explanatory Notes

(These notes form no part of the Bill but are intended only to indicate its general purport)

The Bill seeks to amend a number of pieces of legislation to provide for certain measures in response to the 2019 Novel Coronavirus (2019-nCoV) pandemic.

Clause 1 would contain the short title of the Act for which this is the Bill.

Clause 2 of the Bill would amend the Motor Vehicles and Road Traffic Act, Chap 48:50 to allow for the continuation of the validity of driving permits, taxi driver licences, badges, certificates or other documents where those documents expire during the period 27th March, 2020 to 31st July, 2020 or such longer period as the Minister may, by Order, specify. The amendment would allow those documents to continue to be valid until 31st August, 2020. A new section 61B would be inserted in the Motor Vehicles and Road Traffic Act, Chap 48:50 to provide for this amendment.

Clause 3 of the Bill would seek to amend the Companies Act, Chap. 81:01 to create a period of amnesty for the penalties for failing to file any documents required to be filed during the period 27th March, 2020 to 31st July, 2020.

Clause 4 of the Bill would seek to amend the Bills of Sale Act, Chap. 82:32 to provide for the continuing validity of bills of sale and transfers or assignments thereof which are not registered, or whose registration is not renewed, in compliance with that Act during the period 27th March, 2020 to 31st July, 2020.

Clause 5 of the Bill would seek to amend the Public Health Ordinance, Ch. 12 No. 4 to provide for the increase in the maximum penalties which may be imposed for the breach of regulations under section 105 of that Ordinance. Section 105 of the Ordinance empowers the Minister with responsibility for health to make regulations to control and prevent the spread of dangerous infectious diseases.

Short title	1. This Act may be cited as the Miscellaneous Provisions [2019 Novel Coronavirus (2019-nCoV)] Bill, 2020.
Chap. 48:50 amended	2. The Motor Vehicles and Road Traffic Act is amended by— <ul style="list-style-type: none"> (a) in section 19, by inserting the following new subsection: <ul style="list-style-type: none"> “(7) Notwithstanding any provision to the contrary contained in this Act, any transfer of registration required to be completed prior to or during the period 27th March, 2020 to 31st July, 2020 shall be extended to 31st August, 2020 or such later date as the Minister may, by Order, specify. (b) inserting after section 61A, the following section: <ul style="list-style-type: none"> “Continuation of validity 61B. (1) Notwithstanding any provision to the contrary contained in this Act, any driving permit, taxi driver licence, badge, certificate or other document issued by the Licensing Authority which expired prior to or during the period 27th March, 2020 to 31st July, 2020 shall be deemed to be valid until 31st August, 2020.”.
Chap 81:01 amended	3. The Companies Act is amended in section 516A in— <ul style="list-style-type: none"> (a) subsection (1), by inserting after the words “, where the documents are delivered to or filed with the Registrar “prior to or

during the period 27th March, 2020 to 31st July, 2020 or such longer period as the Minister may, by Order, specify"; and

(b) subsection (3), by deleting the words "by 16th September, 2016" and substituting the words "before the expiration of the period specified in subsection (1)".

4. The Bills of Sale Act is amended by—

(a) by inserting after section 9 the following new section:

"Validity of
unregistered
bills of sale
etc. during
specified
period

9A. (1) Notwithstanding section 9, every bill of sale and every transfer or assignment thereof, which is executed prior to or during the period 27th March, 2020 to 31st July, 2020 or such longer period as the Minister may, by Order, specify, but not registered within seven clear days after the execution thereof, shall be deemed to be valid until 31st August, 2020 or such later date as the Minister may, by Order, specify.

(2) The preservation of validity granted under subsection (1) shall not affect the obligation of a person to register a bill of sale and a transfer or assignment pursuant to section 9.

(3) Where a person fails, on or before 31st August, 2020 or any later date specified under subsection (1), to register a bill of sale or a transfer or assignment thereof which is executed prior to

or during the period specified in or under subsection (1) and which is required to be registered within seven clear days under this Act, the penalties that would have arisen in respect of such failure shall be revived and become applicable as if the waiver in subsection (1) had not been granted.”;

(b) inserting after section 17 the following new section:

“Validity of
lapsed bills of
sale, etc.
during
specified
period

17A. (1) Notwithstanding section 17, the registration of a bill of sale which is not renewed and lapses during the period 27th March, 2020 to 31st July, 2020 or such longer period as the Minister may, by Order, specify, shall be deemed to be valid until 31st August, 2020 or such later date as the Minister may, by Order, specify.

(2) The preservation of validity granted under subsection (1) shall not affect the obligation of a person to renew the registration of a bill of sale under section 17.

(3) Where a person fails, on or before 31st August, 2020 or any later date specified under subsection (1), to renew the registration of a bill of sale, the provisions of section 17 shall apply.”.

5. The Public Health Ordinance is amended in section 105 by repealing subsection (3) and substituting the following subsection: Ch. 12 No.4 amended

“(3) There may be attached, by way of penalty, to any breach of any regulation made under this section, a fine not exceeding fifty thousand dollars and a term of imprisonment not exceeding six months.”.

6. The Cinematograph Act is amended by inserting after section 7 the following new section: Chap. 20:10 amended

“Continuation of validity during specified period” 7A. Any licence issued under this Act which expires prior to or during the period 27th March to the 31st July, 2020 shall be deemed to be valid until 31st August, 2020 or such later date as the Minister may, by Order, specify.”.

7. The Registration of Clubs Act is amended by inserting after section 7 the following new section: Chap. 21:01 amended

“Continuation of validity during specified period” 7A. Any licence issued under this Act which expires prior to or during the period 27th March to the 31st July, 2020 shall be deemed to be valid until 31st August, 2020 or such later date as the Minister may, by Order, specify.”.

8. The Theatres and Dance Halls Act is amended by inserting after section 3 the following new section: Chap. 21:03 amended

“Continuation of validity during specified period” 3A. Any licence issued under this Act which expires prior to or during the period 27th March, 2020 to 31st July, 2020, shall be deemed to be valid until 31st August, 2020 or such later date as the Minister may, by Order, specify.

Chap. 84:04

9. The Money Lenders Act is amended by inserting after section 3 the following new section:

“Continuation of validity during specified period”
3A. Any licence issued under this Act which expires prior to or during the period 27th March, 2020 to 31st July, 2020, shall be deemed to be valid until 31st August, 2020 or such later date as the Minister may, by Order, specify.”.

10. The Pawnbrokers Act is amended by inserting after section 32 the following new section:

“Continuation of validity during specified period”
32A. Any licence issued under this Act which expires prior to or during the period 27th March, 2020 to 31st July, 2020, shall be deemed to be valid until 31st August, 2020 or such later date as the Minister may, by Order, specify.”.

Chap. 84:06

11. The Licensing of Dealers (Precious Metals and Stones) Act is amended in section 4 by inserting after subsection (4) the following new subsection:

“(4) Any licence issued under this Act which expires prior to or during the period 27th March, 2020 to 31st July, 2020, shall be deemed to be valid until 31st August, 2020 or such later date as the Minister may, by Order, specify.”.

12. The Old Metal and Marine Stores Act is amended by inserting after section 4 the following new section:

“Continuation of validity during specified period”
4A. Any licence issued under this Act which expires prior to or during the period 27th March, 2020 to 31st July, 2020, shall be deemed to be

valid until 31st August, 2020 or such later date as the Minister may, by Order, specify.”.
