**SUBJECT : Second Report of the Joint Select Committee on Social
Services and Public Administration -
Recommendation Pertaining to the Companies Registry**

Reference is made to the matter at caption and to the memorandum dated 7 June, 2022 addressed to the Registrar General from the Honourable Attorney General.

The findings and recommendations of the Joint Select Committee on Social Services and Public Administration Committee (JSC) relevant to the Companies Registry, Registrar General's Department (RGD) are duly noted.

The Companies Registry RGD is tasked with the responsibility for the incorporation of limited liability companies, registration of businesses and the regulation of these entities.

It is noted that the Ministry of Trade and Industry (MOTI) has a Business Support and Facilitation Unit, with the responsibility for, *inter alia*, the Creative Industries whose mandate is to stimulate and facilitate the business development and export activities through their State Agencies i.e. the Trinidad and Tobago Creative Industries Company Limited (CreativeTT) and its three subsidiaries, The Trinidad and Tobago Film Company Limited (FilmTT), The Trinidad and Tobago Music Company Limited (MusicTT) and The Trinidad and Tobago Fashion Company Limited (FashionTT).

In light of the role of the Companies Registry, and that of the State Agencies of the MOTI, the Companies Registry, and by extension the RGD, can assist with training in registration and incorporation procedures in support of this initiative.

The Companies Registry is currently heavily engaged in activities for the roll out of the new Companies Registry Online System (CROS) which is a transition from a paper based environment to a fully digital online system.

Accordingly, this may be an opportune time to promote CROS to the general public and to train persons in the Creative Industry in the processes and procedures of registration of businesses and incorporation of companies.

In light thereof the Companies Registry will be willing to undertake this aspect of an engagement with the Creative Industries.
